



## **RACWA Win an electric car Promotion** **TERMS AND CONDITIONS**

1. The promoter of the Win an electric car Promotion (Competition) is The Royal Automobile Club of WA (Inc.) ABN 33 212 133 120 (the Promoter).
2. The Competition begins on 20 January 2016 at 9.00am (Australian Western Standard Time) and ends on 30 April 2016 at 11.59pm (Australian Western Standard Time) (Competition Period).
3. Entries must be received by the Promoter during the Competition Period. Only one entry may be received per entrant.
4. The Promoter reserves the right to either allow or disallow any entrant for any reason it sees fit in its absolute discretion.
5. Entry to the Competition is only open to current Members of The Royal Automobile Club of Western Australia who reside within Western Australia.
6. Entry to the Competition is not open to employees of the RAC Group of Companies
7. Up to 5 entrants (Winner/s) may each be awarded only one prize (Prizes) as follows:

### First prize:

- 1x BMW i3 electric vehicle valued approximately \$79,000 including 12 months registration and installation of home charging facilities
- 12 months RAC Classic Roadside Assistance valid from the date of handover

### Conditions applicable to all prize winners

  - Driver of the electric vehicle must be over 18 years of age and provide evidence of current drivers licence.
  - Prizes are self-drive itineraries and winners are subject to adhere to all RAC Electric Car terms and conditions.
  - All properties are Star Rated 3.5 stars or above. Accommodation type can be any of the following; Resorts, Hotels, Motels, Chalets, Holiday Units and will be defined upon collection of prize. Prize subject to availability. Blackout periods apply.
  - Travel must be completed on the specified dates if defined.
8. This document, the instructions on how to enter the Competition and other details contained within promotional advertisements and the Entry Form (if applicable), each form part of the Terms and Conditions.
  9. The Winner/s shall be chosen by the Judges from the entries at random. Entrants must complete the competition form and get the

Electric Highway® question correct during the promotional period (either via the online form or any paper forms).

10. The Winner/s will be drawn on 8 February, 8 March, 4 April and 26 April 2016 (runner up prizes) and 4 May 2016 (major prize) and notified by phone or writing.
11. When the Winner/s are notified of their Prize they will also be provided with details as to the collection of their Prize.
12. The Judges' decision is final and no correspondence will be entered into. The Promoter reserves the right not to select Winners of all or any Prizes in its absolute discretion.
13. Each Winner must claim its Prize on or before within two days of the prize draw date. Prizes must be claimed in person unless a Winner is otherwise advised. Identification, which includes a photograph, will be required. Prizes will only be awarded following winner validation and verification.

16. The Promoter reserves the right to disqualify a Winner if the Winner has breached any of the Terms and Conditions or their entry is misleading.
17. The Promoter reserves the right to:
  - a. declare as void any entries or claims for Prizes resulting from any printing, production or distribution errors or where there has been error in any aspect of the preparation for or conduct of the Competition materially affecting the result of the Competition or the number of Winners or the value of claims for Prizes;
  - b. add to or to waive any of the Terms and Conditions; and
  - c. cancel the Competition or any part of it at any stage in the event of circumstances beyond the Promoter's control.
18. The Promoter reserves the right, in its sole discretion, to disqualify any individual for:
  - a. tampering with the entry process, including exceeding any limitation on the numbers of entries, or any other process as determined by the Promoter that in any way affects the fairness of the promotion or the website of the Promoter or the Competition;
  - b. acting in violation of the Terms and Conditions.

20. All entries remain the property of the Promoter and may be entered into a database for future marketing or promotional activities. By entering the Competition entrants, in the event that they are a Winner, consent to the publishing of their names and suburb of residence on the website [www.rac.com.au](http://www.rac.com.au).
